All Payments are due in advance. Caretaker is responsible for scheduling the dog for daycare for the following week by Friday evening. If a dog is dropped off on a non -scheduled day without prior notification, you will be charged an additional \$5. If your dog cannot attend daycare on his scheduled day, Pets Pals Home Too, Inc. must be notified 12 hours in advance, other wise you will be charged for the day. All dogs must have a leather or cloth leash no longer than six feet (no flexi leashes), and a quick release buckle collar with their tags. Caretaker (owner) must supply Pets Pals Home Too, Inc., with all training aids, food and medication . Dog's nails must be kept at a reasonable length so others don't get scratched.

Limo Service for Boarding is a minimum of \$20 on weekends and \$15 on weekdays. These services are limited.

We prefer to receive your pup as early in the day as possible so he/she can play before dinner we accept dogs as late as 6 p.m. If you checkout by 8:30 a.m. there is no charge for that day. If you checkout between 8:30 a.m. and 6 p.m. you will be charged for daycare (presently \$22.) After 6 p.m. the rate is for a full day. Weekends are full day rate regardless of pickup time. After hours and weekend pickup is \$15 and by appointment only. If you do not show or call for an appointment you will have to pickup on Monday or the next business day and you will be charged.

Cancellation/Refund Policy: In the event that you must cancel a stay it must be done a minimum of 24 hours in advance (72 for holidays) your deposit will be applied to your furkids next visit. If you have not cancelled in a timely manner you will be charged a minimum of one night (50% on holidays.) If you have done a No Call/No Show you will be required to provide us with a non-refundable 50% deposit for future reservations that is due at the time you make your reservation. If you pickup your furkid early we do not offer refunds. We will apply any monies paid to your next visit. All credits must be used within 6 months and may be applied to either boarding or daycare.

If you are not available, we will contact your veterinarian. Should your dog require veterinary attention, and we determine in our sole discretion, that the time exists to safely transport your dog to your veterinarian; we may do so as an option. At Pets Pals Home Too sole discretion, your dog may be taken to an emergency veterinary clinic, or the veterinarian of Pets Pals Home Too choice. It is understood that all expenses incurred to your dog's illness or accident must be paid in full at the time that you pick up your dog from Pets Pals Home Too. We will not bill you or accept partial payment. There will be a \$20 trip charge per visit to veterinarian.

I (we) agree to hold Pets Pals Home Too, Inc., its members, directors, officers, agents, and the owner or lesser of business premises and any employees of aforementioned parties harmless from any claim for loss or injury which maybe alleged to have been caused directly or indirectly to any person or thing by the act of my dog, and I (we) personally assume all responsibility and liability for any such claim. Further, I (we) further agree to hold the aforementioned parties harmless from any claim for loss of my dog by disappearance, theft, death or otherwise, and from any claim to damage or injury to the dog, whether such loss disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the organization or any of the parties of aforementioned, or by the negligence of the person, or any other cause or causes I (we) assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense, (including legal fees), by reason of the liability imposed by law or persons, including myself (ourselves) upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person and persons, including my self (ourselves), howsoever such injuries, death or damage to property may be caused, and whether of not the same may have been caused or alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, trainers or any other persons. I have read and understand all of the statements in this agreement and agree to be bound by these statements and agreements.

I, the Client, authorize Pets Pals Home Too, Inc. to perform pet care services for my pet. My pet is current on all vaccinations and licenses. **I certify that my pet has not been ill with any communicable condition in the last 30 days.** I understand that Pets Pals Home Too, Inc. will not accept dogs unless they have been spayed or neutered.

I understand and agree that my dog(s) will at all times while attending Pets Pals Home Too, Inc., have current vaccination status. I further understand that even if my dog is vaccinated for Bordatella (Kennel Cough) there is a chance that my dog can still contract Kennel Cough. I agree that I will NOT hold Pets Pals Home Too, Inc. responsible if my dog(s) contracts Kennel Cough. I understand that having my dog in the company and environment of other dogs may involve risks regarding the contraction of illness. I understand that even regular vaccinations cannot completely guard against illness and disease, and that Pets Pals Home Too, Inc. cannot in any way prevent, nor are they responsible for, any illness that my dog might contract.

I understand that there are risks inherent in having my dog boarded in an environment where the dogs are not kept in cages and are around other dogs and people. I understand that it is not always possible for Pets Pals Home Too, Inc. to prevent injuries that may occur during play. All dog play is monitored by Pets Pals Home Too, Inc. to avoid injury, but scratches, punctures, torn ligaments, etc., may occur despite supervision. I understand and agree, that Pets Pals Home Too, Inc., its employees, staff or volunteers, will not be liable for any illness, injury, death, and/or escape of my dog. I acknowledge that Pets Pals Home Too, Inc., its employees, staff or volunteers will take such actions as are reasonable to minimize these risks. I will be responsible for the actions of my dog if it causes any damage whatsoever, including but not limited to damage or injury to other dogs, people, or objects while in the care of Pets Pals Home Too, Inc.. I further understand and agree that my dog will have access to a fenced outside area and I agree to assume full liability if my dog escapes.

I warrant that my dog(s) is/are suitable to be in the care of Pets Pals Home Too, Inc. and is/are in good health and have not harmed, shown aggression or exhibited any threatening behavior

towards any person or other dog. My dog is obedient and capable of following instructions. I further understand and agree that Pets Pals Home Too, Inc. reserves the right to use a bark control device, if my dog(s) creates a disturbance to the neighborhood. I will immediately advise Pets Pals Home Too, Inc. of any problems with my dog that could affect its behavior, health or suitability for a communal living environment and play activities.

I understand that there are risks involved in having my dog cared for by Pets Pals Home Too, Inc.. In the event of illness or injury, I authorize Pets Pals Home Too, Inc. to take my dog to the nearest vet considered to be the most suitable by Pets Pals Home Too, Inc., its directors, shareholders, employees or servants, should Pets Pals Home Too, Inc. deem it advisable. I agree to pay all vet care required or advised, in the opinion of the vet, to the amount specified on my Veterinarian Authorization Form. If the required care will exceed that amount, I know that Pets Pals Home Too, Inc. will try to contact me at the telephone numbers I have given when placing reservations for my dog(s). If they cannot reach me, Pets Pals Home Too, Inc. is authorized to use their best judgment in deciding whether to go ahead with any form of treatment recommended by the vet, whether the cost of such treatment exceeds my maximum amount specified on the Veterinarian Authorization Form or otherwise, and I agree to pay for all such care. I hereby release Pets Pals Home Too, Inc. from all liabilities related to transportation, treatment, prescribed medications and expense. I agree to reimburse Pets Pals Home Too, Inc. for any additional fees for tending to emergency care as well as any expenses incurred for any other unexpected veterinary, food or other supply needs. I assume full financial responsibility for any and all expenses involved.

I represent and warrant to Pets Pals Home Too, Inc. that I have fully disclosed to it any history which my pet(s) may have of aggression, biting or causing other injury or damage to person, other animals or property, and I understand that Pets Pals Home Too, Inc. reserves the right to refuse service as a result thereof. Client will be liable for medical care expenses and damages that result from an animal bite. I further understand and agree that Pets Pals Home Too, Inc. and their staff will not be liable for any problem(s) that develop, and I hereby release them of any liability of any kind arising from my dog's attendance and participation at Pets Pals Home Too, Inc..

I further understand and agree that if my dog(s) is/are not picked up by the end of the Pets Pals Home Too, Inc. regular business day, then I hereby expressly authorize Pets Pals Home Too, Inc. to take whatever action is deemed necessary for the continuing care of my dog(s) and I agree and promise to pay to Pets Pals Home Too, Inc. all costs of continuing such care upon demand by Pets Pals Home Too, Inc.. Further, I understand that if I do not pick up my dog(s) as scheduled, Pets Pals Home Too, Inc. shall be authorized to proceed according Florida Statute 828.

I further understand and expressly agree that each and every of the foregoing provisions contained in all paragraphs above shall be in force and effect and shall apply to each and every occasion on which I board or deposit my dog(s) with Pets Pals Home Too, Inc. for daycare, or extended boarding, as the case may be; and that this Agreement shall remain in full force and effect as between the parties until and unless otherwise cancelled or superceded by a writing signed by the parties.

This service contract shall be governed by and construed in accordance with the internal laws of the State of Florida applicable to contracts to be performed wholly within the State, without giving effect to the law or conflicts of laws applied thereby.
